



BELLE MEADE HOME OWNERS ASSOCIATION SATELLITE
DISH AND ANTENNA POLICY

1. Areas Under an Owner's Exclusive Use and Control.

(a) **Dishes.** Satellite dishes and antenna designed to receive video programming services via multi-point distribution services may be installed in an area under an Owner's exclusive use or control so long as such antenna and satellite dishes are (i) one meter or less in diameter, (ii) installed in the least visually obtrusive portion of an Owner's property, near the rear, out of sight from the street, where an acceptable quality signal can be received, so long as such installation is not unreasonably expensive, (iii) either screened from view or painted to match the surrounding area so as to blend in with the surrounding area, so long as such screening or painting is not unreasonably expensive, and (iv) any unused satellite dishes must be removed prior to the installation of a new dish.

(b) **Broadcast Antenna.** Antenna designed to receive television broadcast signals may be installed in an area under an Owner's exclusive use or control so long as (i) an acceptable quality signal cannot be received via an indoor antenna (e.g., an antenna mounted in an attic, "rabbit ears," etc.), (ii) the antenna used is the smallest size available at a reasonable cost that receives an acceptable quality signal, (iii) installed in the least visually obtrusive portion of an Owner's property, near the rear, out of sight from the street, where an acceptable quality signal can be received, so long as such installation is not unreasonably expensive, and (iv) any unused antenna must be removed prior to the installation of a new antenna.

(c) **Notification.** After installing an outdoor antenna or satellite dish pursuant to Paragraph (a) or (b) above, the Owner must complete and submit a Notification form to the Association. The Association will inspect the antenna or satellite dish to determine compliance with the above requirements.

2. Areas Not Under an Owner's Exclusive Use or Control.

Owners are not permitted to install satellite dishes and antenna in areas that are not under the Owner's exclusive use or control. Such areas include Common Property, including but not limited to, landscaped areas, or any property/structure maintained by the Association.
